## Enter to Win

To be entered to win, Yolo Federal Credit Union members will share their story about how Yolo Federal has helped them achieve their financial dreams. There will be a quarterly drawing of one winner to receive the \$650 prize.

**SPONSORSHIP:** Yolo Federal Credit Union (Yolo FCU), a federally chartered credit union with a principal office located at 266 W. Main Street, Woodland, CA 95695, is sponsoring the 65<sup>th</sup> Anniversary Contest.

**ELIGIBILITY:** To enter the Contest, entrants must be a current Yolo Federal Credit Union member and in good standing with the credit union, a lawful permanent resident of the United States, 18 years of age or older and must not be considered a minor in your state of residence. The Contest is void in Puerto Rico, U.S. territories and possessions, outside of the United States, and where restricted or prohibited by law. Credit Union employees, officials, and members of their immediate families and households are not eligible to participate in the Contest. **HOW TO ENTER:** To be entered to win, Yolo Federal Credit Union members will submit their story about how Yolo Federal has helped them achieve their financial dreams through the contest webpage <u>http://www.yolofcu.org/65th-anniversary-contest/</u>. Only one submission per person will be considered for entry.

**DRAWING:** A random drawing will be held for qualifying entries received during the Entry Period (see below) on or around the last day of each quarter. Potential winners will be selected from all eligible entries received during the Entry Periods described below, by a Yolo FCU representative. Odds of winning the prize depends on the number of entries received. The potential winners will be notified by phone, e-mail or mail. If a potential winner cannot be reached within thirty (30) days from the first notification attempt, then such person shall be disqualified, and an alternate winner will be selected.

**PRIZE:** There will be 4 total winners awarded \$650 for entering the contest – 1 per quarter. Yolo FCU will report all prize winnings to the appropriate state and federal agencies, as required by applicable law. Winners are responsible for all tax consequences (if any) of the prizes. Winners acknowledge this responsibility by entering the contest. To claim prize, entrants must meet all eligibility requirements.

**PRIZE CONDITIONS:** In the event a Yolo FCU representative determines, in its sole discretion based on his/her interpretation of these Official Rules, that an entrant is found to be ineligible, or if he/she does not comply with these Official Rules, then the potential winner will be disqualified and an alternate winner will be selected through a random drawing from the remaining entries. If the prize or prize notification is returned as undeliverable, this will result in disqualification, and an alternate winner will be selected. Except where prohibited by law, the winner's entry and acceptance of the prize constitutes permission for Yolo FCU to use said winner's name in all forms of media, in perpetuity, without further compensation. Further, winner must sign and return to Yolo FCU a declaration of eligibility and liability publicity release. The release may be mailed to "65<sup>th</sup> Anniversary Contest" P.O.
